

#### **Additional Details relating to the Baseline Emissions calculations**

Baseline Emissions (and Current Emissions) have been calculated by taking the total UK emissions of Baywater Healthcare UK Limited and apportioning the emissions for each scope.

The baseline figures have been taken from 2020 when Baywater Healthcare commissioned a third party organisation to assess Carbon emissions for reporting purposes.

During the Covid-19 pandemic, our offices were closed for long periods and business activities were reduced. In addition, we won and mobilised additional contracts which are set to increase our activity. Both of these elements greatly impact our emissions and footprint. We expect to record in 2022, baseline figures that more accurately reflect "Business as Usual".



## **Carbon Reduction Projects**

#### **Completed Carbon Reduction Initiatives**

The following environmental management measures and projects have been completed or implemented since the 2020 baseline. The carbon emission reduction achieved by these schemes equates to 15314.17 tCO2e, a 24% reduction against the 2020 baseline and the measures will be in effect when delivering our services.

These schemes below have contributed to a reduction in greenhouse gas emissions and the measures will be in effect when delivering services under contract.

We are not currently able to calculate the tCO2e reduction achieved by these schemes or the corresponding percentage reduction achieved against the 2020 baseline.

During 2020/21, energy efficiency measures have been implemented at a number of sites across Baywater Healthcare. The most notable include LED lighting replacements at all sites and the introduction of hybrid vehicles. In addition, we are encouraging a continuation of virtual meetings in lieu of face-to-face attendance on site at client, supplier or our own office sites.

#### In the future we hope to implement further measures such as

- Move to a fully electric fleet
- Switch to 100% renewable energy provider
- Encouraging remote working and virtual meetings to reduce business travel by over 40%
- · Closely working with suppliers to influence their commitments to reducing Carbon emissions
